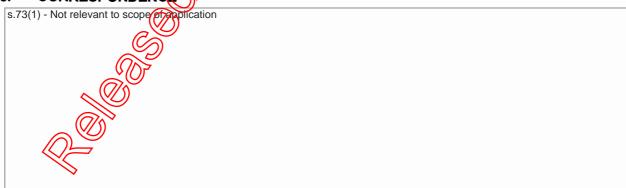

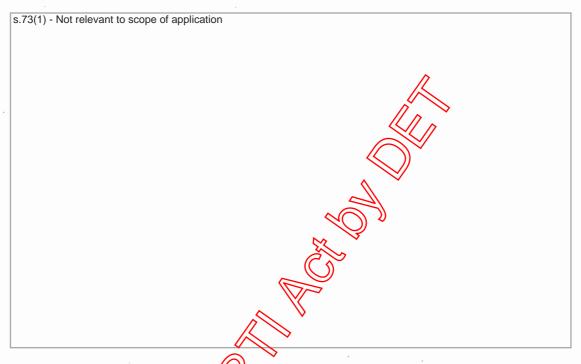

#### 6.3.1 Maridahdi Early Childhood Community School, South Street site

The Board considered the correspondence (dated 29 March 2010, received 31 March 2010) from Maridahdi Early Childhood Community in relation to zoning and land-use matters at the proposed 1 South Street, Toowoomba site of Maridahdi Early Childhood Community School.

The Board noted that:
